Conditions

- Casuals and members must sign in prior to each group fitness class and gym session.
- Minimum dress requirements are singlet or t-shirt, shorts, track pants or tights and appropriate closed in footwear. No bare feet, work boots or thongs.
- All casuals and members must bring and use a sweat towel to maintain hygiene standards.
- Children under 16 are not permitted in the gym unless authorized by Management.
- Photography and video is not allowed, unless permission is given by the people in the footage.
- All weights and equipment must be put away after use.
- Memberships may be placed on hold for a minimum of one week and a maximum of one year, provided notice is given.
- Photo identification is required on sign-up.
- Access to the gym is restricted to the Living Longer, Living Stronger program every Monday, Wednesday and Thursday between 1pm and 2pm.
- Use of the gym facilities and equipment is at members own risk.
- All gym users should be treated equally and with respect.

Cooling off period

This agreement is subject to a 7 day cooling off period. A member may terminate this agreement with the Harvey Recreation and Cultural Centre without cause or reason during the cooling off period by providing written notice of termination.

Written notice and a copy of the medical certificate should be given to Harvey Recreation and Cultural Centre. Cancellation will take effect immediately in this case.

This agreement may also be cancelled for any reason by giving written notice to the Harvey Recreation and Cultural Centre.

No fee will be charged for cancellation however refunds will be on a case-by-case basis with consultation with Harvey Recreation and Cultural Centre management.
